

## Information – Transportation service permit

Use of the transportation service (Färdtjänst) can be granted to a person who, because of a disability lasting at least three months, has considerable difficulty moving around on their own or travelling using public transport.

Accessibility on public transport for anyone with a disability is therefore a key factor when making an assessment. Use of the transportation service is not granted due to a lack of public transport. The decision is based purely on your disability. A transportation service permit can be combined with individual terms and conditions.

Länstrafiken is responsible for the transportation service in the county, and it makes an assessment following receipt of your application. Information regarding an application is obtained in the first instance from the applicant. Information from other sources is not obtained without the verbal or written consent of the applicant. Information provided by you and other parties will be stored in a personal data register. Information is protected and processed according to the stipulations in the Public Access to Information and Secrecy Act and the European General Data Protection Regulation (GDPR). A written application must be submitted for each journey and must, if necessary, be accompanied by a medical statement. A decision will be notified in writing. An assessment will be made as quickly as possible following receipt of your application.
