

Information – Transportation Service

Use of the Special Transport Service can be approved for a person who, because of a functional impairment lasting at least three months, has considerable difficulty moving around on their own or travelling using public transport. Accessibility on public transport for those with a functional impairment is thus an influencing factor in the assessment. Use of the Transportation Service is not granted due to a lack of public transport. The only deciding factor is your functional impairment. A Transportation Service permit can be combined with individual stipulations, terms and conditions.


Region Örebro län is responsible for the Transportation Service in the county and makes an assessment following receipt of your application. Information about the applicant is obtained in the first instance directly from the person in question. Information from other persons is not obtained without the verbal or written consent of the applicant. Information provided by you and other persons will be stored in a personal data register. Information is protected and processed according to the stipulations in the Public Access to Information and Secrecy Act, and in the European General Data Protection Regulation (GDPR). The application must be in writing and, if necessary, be accompanied by a medical statement. You will be notified of the decision in writing. The assessment will be made as quickly as possible following receipt of your application.
